Section 30-4-20(c)

[SC Code of Laws Section 30-4-70(b): Before going into executive session the public agency shall vote in public on the question and when the vote is favorable, the presiding officer shall announce the specific purpose of the executive session.]

\*To review applications for the Director position, possibly interview applicants for same, and possibly hire a Director; to receive and discuss findings from the BVR&ECC Board attorney regarding personnel matters; to receive and discuss findings from the BVR&ECC Budget Review Committee; and to review and discuss security matters related to the election process.
